How to apply for a Boys & Girls Club Scholarship

1

Parents or guardians please complete the scholarship form, and return it to BGC along with a copy of your tax return for proof of income, and a membership application for new members.

2

Please select the type of scholarship desired: Summer Vacation Camp, Transportation, or Semester Fees. Scholarships are limited to 1 per family, 3 children maximum per family.

3

Scholarships are awarded to existing members first, based upon need, then open to new members, if availability exists, on a first-come first served basis.

4

Applications will be reviewed and parents/guardians notified. Summer scholarship decisions will be made 8 weeks before start of summer vacation, and open to new members 4 weeks before the start of summer vacation.

There are three qualifications to be eligible to receive a BGC scholarship:

1. Child must be an existing and active Boys & Girls Club member and your existing account balance must be current. New members will be accepted only if scholarships are available after active members have been selected.
2. Family income may not be more than 125% of the federal poverty level (see chart for amounts). *A copy of a parent's Tax Return is required with the scholarship application.*
3. A maximum of three (3) children in a family may qualify for a scholarship. Children must be between 5 to 18 years of age.

If a child fails to meet any of the qualifications a scholarship will not be issued. Parents/guardians with three (3) or more children may make payment plan arrangements —please contact your Unit Director.

Return completed forms to the Boys & Girls Club of which your child will be attending.
