Classroom Training

We assist motivated participants in earning a certificate, degree or GED to further their educational goals. Chosen applicants are paid a stipend for up to 120 hours of classroom time. Participants are also required to complete financial literacy training that introduces credit, banking, and checking and savings account management.



TO QUALIFY

- You must be a U.S. citizen, legal permanent resident, refugee, or other individual authorized to work in the U.S
- You must be a farmworker or the dependent of a farmworker
- You must be part of a disadvantaged or low-income household

There are additional eligibility requirements, so please contact us to determine if you and your family qualify.
